Thank you for your interest in purchasing professional use rodenticide.

As I'm sure you are aware the sale of professional use rodenticides is controlled. This ensures that only persons or organisations which can demonstrate a level of competency set out in the CRRU code of practice can purchase professional use rodenticides, i.e anticoagulants that are greater in strength than 0.003% and other products labelled for professional use.

The products that we have available all meet the criteria set out by the CRRU Code of practice and as a responsible seller of professional products we uphold this code at all times.

Fort products hold accreditation from BASIS who undertake an annual audit of our operation to ensure that the criteria of the code of best practice are met.

In order for your purchase to be completed we require the submission of the following documents. These documents ensure that products are only supplied to those that are permitted to use these tools responsibly.

There are **three** documents that you need to supply either electronically or by mail. Please note that for electronic documents to be accepted a physical signature is needed.

**Document 1** – Account setup document – we need this so that we have a signed record of who we are supplying to.

**Document 2** – A copy of either your professional qualification or in date evidence of an approved farm assurance scheme membership. An up to date list of these can be found at
